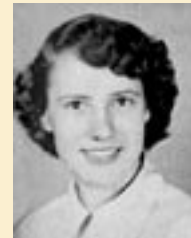

SENIOR Spotlight —1939 William Zink

“In reading your CONNECTIONS, I just thought to send you some interesting information. I was the youngest graduate of S-C High in 1939; I was 16 yrs. of age and graduated in the top 25%. I started

school on a homestead in Wyoming, but we moved back in 1929. I was born in December 1922 in Green Ridge, MO, the 2nd oldest, after my sister. I spent 4 years in the Air Corps during the 2nd World War in England. I spent the years after the war up and down the Rockies from Las Vegas and Northern Mexico, to Bozeman, MT. We celebrated our 50th anniversary with all our kids, except one who died of Cystic Fibrosis. I moved to Lingle, WY with my daughter, Doris, whose husband runs a large corn farm and cattle feedlot. I will celebrate my 90th birthday in December, and I feel good! If there is a 1939 reunion, I might be able to attend. Hopefully, W.K. Zink”
